Read all instructions and fully understand them before installing you TS Performance MP-8 module.

Disconnect the battery terminals and remove keys from ignition before installation.

Place Di-Electric Grease onto every electrical connection.

- 1. Find a proper location for mounting the module. Use the supplied Velcro to fasten the module away from extreme heat and moisture.
- 2. Locate the 15 pin connector found on the passenger side of engine. The fuel sensor signal and power wires are integrated into this connector.
- 3. Disconnect the plug and connect our supplied connectors in-line.
- 4. Route the adjustable switch wire through the firewall to the MP-8 module.
- 5. Mount the switch on the dash where it can be accessed by the drive.
- 6. Re-connect the battery terminals.
