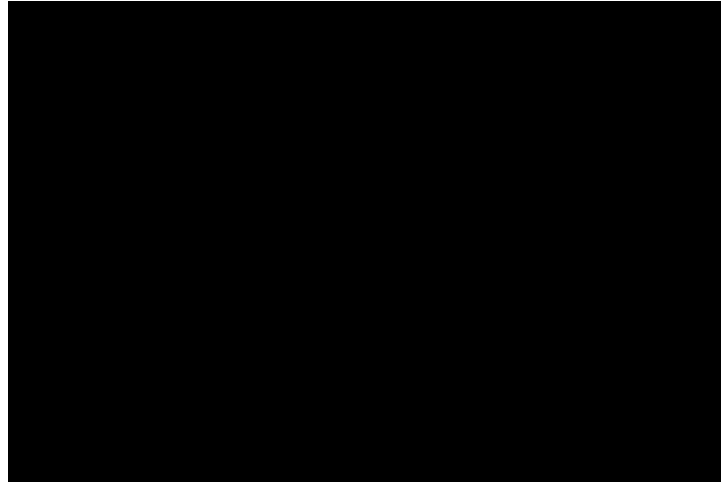

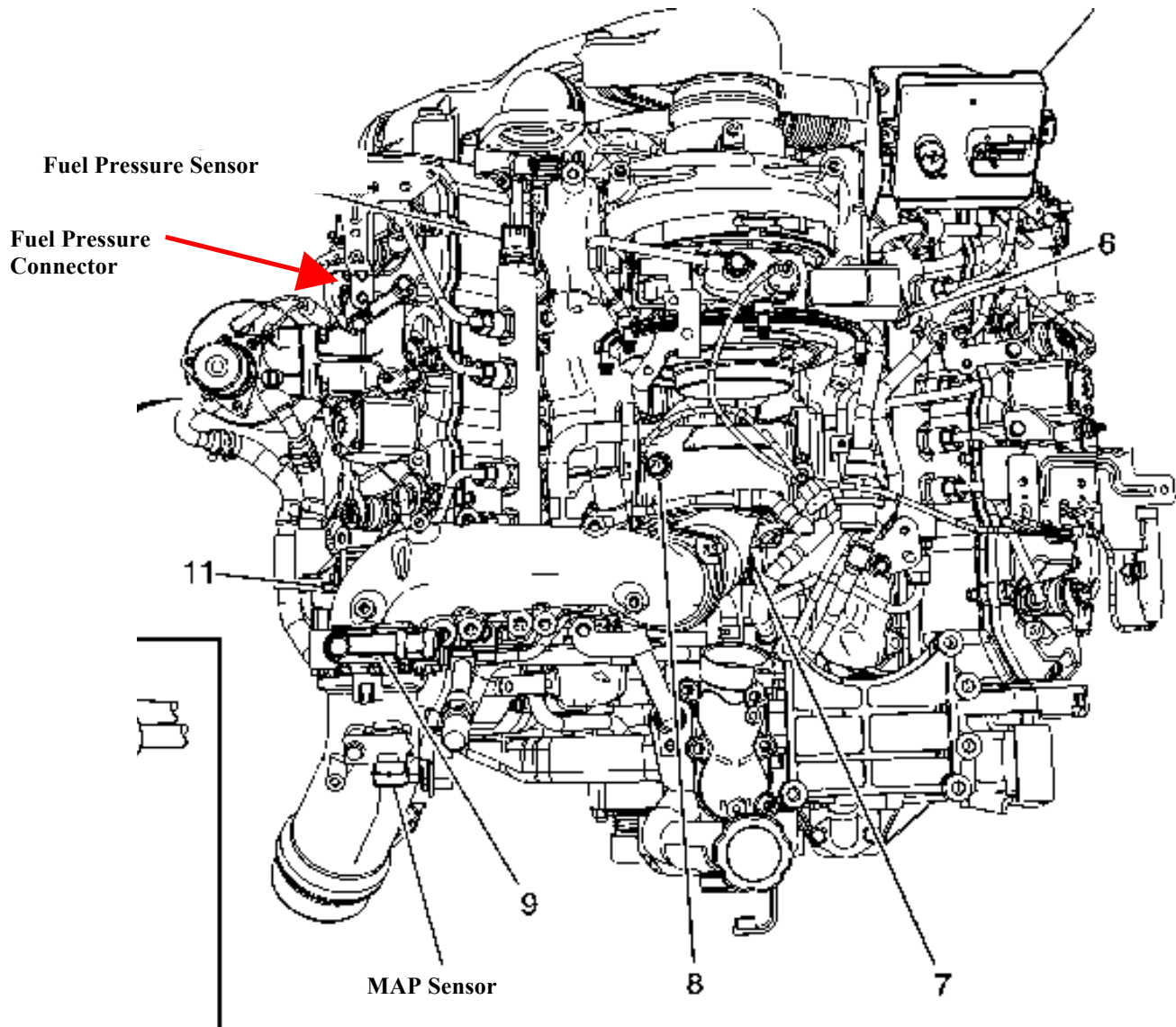

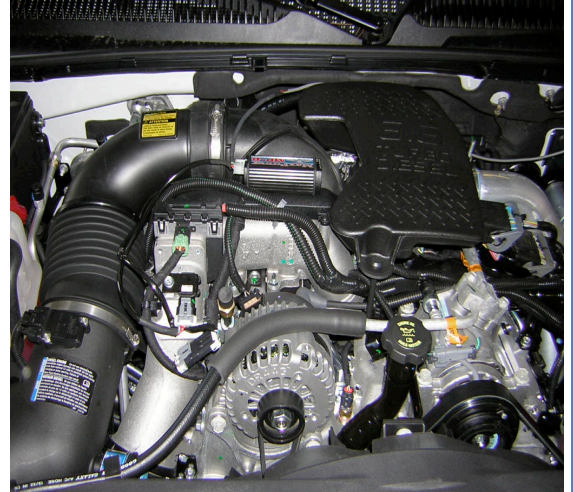
## **Installation of TS Performance Power Play MP-8 6.6 Duramax LMM**

**Read all instructions and fully understand them before installing your TS Performance MP-8 module. Disconnect battery terminals and remove keys from the ignition before installation. Place Di-Electric Grease onto every electrical connection.**



## **Continued**

1. Find the proper location for mounting the module itself. This should be a dry location using the supplied Velcro to securely mount it.
2. Route the switch wire through the firewall to the MP-8. We recommend making a small hole in a boot and running the wire through there. Make sure not to cut any wires when making the hole.
3. Locate the MAP Sensor. The connector will be a three pin connector as seen in the picture. Use the supplied connectors and plug into the MAP Sensor and factory harness.  
On the LMM engine the MAP Sensor is located on the front air intake manifold tube on the front of the engine as shown in the picture to the right.
4. Now you will need to locate the Fuel Pressure Connector. On the LMM engines the Fuel Pressure Connector is located on the passenger's side valve cover. There are 2 connectors side by side and you will want to disconnect the black connector. Now connect our harness to the male and female side of this connector.
5. Now you need to decide where you want to mount your adjustable switch. We suggest using the area just to the left of the airbag shut-off switch. If you do not want to drill your dash you can also hang the switch beside the steering column.



A Shim Kit must also be installed when installing the MP-8 module. If the shim kit is not installed correctly it can set a Check Engine Light. Your Shim Kit Instructions are listed in a separate set of instructions.
